Current expected balance appears better than June estimates. June 2023 estimates were based on conference attendance in fall 2022.

Finally, the only IOSS expenses remaining are the student scholarship and insurance.

Early comparison of debits and expenses per conference only

Conference debits: \$3006.91 Conference credits: \$3376.78

Currently \$369.87 in black for conference debit and credit comparison

• Last year at this time, the comparison was \$470.67 in red

Brief summary of annual anticipated finances based on above numbers

Remaining annual debits before the 2024 conference include \$700.00 more in expenses (scholarship at \$500 and insurance at \$200) for the remainder of the year. **That will leave us with \$5377.27 for planning for the fall.**

For the **annual change** in the IOSS account, then, we will be **\$330.13** in the red, which is *much better* than last year when the loss exceeded **\$1000**.

A slight increase in attendance beyond even the 2023 attendance and we could be in the black for our annual account change.
