# DMACC Pioneers keep helping

Des Moines Area Community College (DMACC) recently started a program for retired staff members who served the college for 10 or more years. The DMACC Pioneers is a group of about 50 people who want to continue service to the school.

Leonard Bengtson, president of the DMACC Pioneers, said although there are about 50 in the group, only about 35 live

## **DMACC Pioneers: The Beginning**

The DMACC Pioneers is a group of retired DMACC employees who remain active in DMACC events and provide service and support to the College through special projects and activities including raising money for scholarships for DMACC students. (Pioneer website) The idea for such a group began with Joe Borgen, Leonard Bengtson, and Don Kerr in 1993. After researching organizations at other colleges, the men were not satisfied with what they found, so they decided to create their own approach to the group. A group of retired secretaries had already been formed. They decided to merge with the Pioneers. A Pioneers constitution was written and approved by the college in August of 1994. Those who served as the first officers were Leonard Bengtson, President; Pauline Skarda, Vice President; Millie Kerr, Secretary; and Dona Danaher, Martha Pestotnik, Irv Steinberg, Curt Smith as Members-at-Large.

The goals of the group were to keep members in touch with what was happening at DMACC, to provide service to DMACC by volunteering, to provide communication and social contact for members, and to provide members with information/topics that are important to retired people.

The first meeting was held September 8, 1994. The initial group was about 50 people. At the first meeting, Dale Wagner presented an overview of the college taken from a document prepared by Bengtson. "In March of 1965, the State Board of Public Instruction approved establishment of the college and designated its district as Merged Area XI. In August, Paul Lowery was hired as the College's first superintendent. In February of 1967, 28 students were admitted in four programs at the first instructional site at 2801 Vine Street in West Des Moines."

Original benefits to members included being able to take a free class if an open seat in the class, using library privileges, receiving DMACC Bulletin, using college nurse for blood pressure checks, etc., participating in Wellness program at the same rate at Wellness members, using gym and exercise facility, participation in retirement functions. (Trail Point membership at employee rates was offered in 2017.)

Initially, membership requirements for the Pioneers required that employees work ten years at DMACC. On July 10, 1997, an amendment was proposed to reduce the number of years of service at DMACC to five. It was approved by letter ballot. On September 10, 1996, the decision was made not to require dues for Pioneers. The Constitution was revised in 2003 to allow voting on decisions to be made by members attending Pioneers meetings and to create procedures and time-lines for electing officers and members-at-large. (Jim Dowis, Pioneers President and Dale Wagner, Constitution Committee.)

The first committees were Membership, Garage Sale, Fundraising, Volunteer, and Meetings. With the approach of the 50<sup>th</sup> Anniversary of DMACC, President Denson asked the Pioneers to form a History Committee to gather history of the college and preserve it in a digital archive. Dale Wagner was the first Historian. Carroll Bennett served as an early Chair of the History Committee. Communications Director was added in 2016 with Dee Johnson serving first in that position.

### CONSTITUTION

### **ARTICLE I: NAME AND PURPOSES**

Section A. NAME

The name of this organization shall be the DMACC Pioneers.

### Section B. PURPOSES

- To provide financial support and services to Des Moines Area Community College (DMACC) and DMACC students, administered through the DMACC Foundation.
- To provide opportunities for members to maintain contact with DMACC and to remain informed concerning its continued development.
- To promote continued friendship and fellowship among members.

### **ARTICLE II: MEMBERSHIP**

Section A. REGULAR MEMBERSHIP

Any person who is an early or regular retiree, or one who has left permanent full or part time employment with the College, after a minimum of five years of such service is eligible for Regular Membership.

Section B. ASSOCIATE MEMBERSHIP

Individuals who have rendered significant services to DMACC over a period of time, a minimum of five years, and who were either long-term temporary or adjunct employees, Ex-DMACC Board members, or Department of Education retirees.

## ARTICLE III: STRUCTURE OF THE ORGANIZATION

Section A. OFFICERS

Officers of the DMACC Pioneers shall be President, Vice-President, Secretary, Treasurer and Immediate Past President

### Section B. LEADERSHIP COUNCIL

The membership of the Leadership Council shall include President, Vice-President, Secretary Treasurer, six members-at-large, Immediate Past President and DMACC Liaison.

Section C. RELATIONSHIP WITH THE COLLEGE The DMACC President and DMACC Foundation will appoint a member of the DMACC staff to serve as Liaison between DMACC, the DMACC Foundation and the Pioneers. Such appointment shall be a continuing one until a new appointee is named. The Liaison representative shall serve as an ex-officio member of the Leadership Council. In addition to the Liaison representative, the College provides assistance and support to the Pioneers in a number of ways, including but not necessarily limited to:

- Providing facilities for regular meetings of the Leadership Council and for DMACC Pioneer group functions, as appropriate and available.
- Processing of financial transactions through the DMACC Foundation and DMACC Business Office.
- 3. Access to office space.
- Limited clerical assistance as appropriate and arranged by the Liaison representative.

### Section D. RULES OF ORDER

Robert's Rules of Order Revised, by Henry Martin Robert shall govern the proceedings of the organization unless otherwise specified.

### ARTICLE IV: AMENDMENTS

Section A. This Constitution may be amended by a twothirds vote of the Leadership Council followed by approval of 60% of those members in attendance at the meeting in which the vote is taken.

Section B. Members of the DMACC Pioneers will be notified of proposed changes to this Constitution through an announcement in the DMACC Bulletin for two publications.

## PROCEDURES OF THE DMACC PIONEERS ARTICLE I: MEMBERSHIP

Section A. The Leadership Council shall be responsible for membership recruitment and promotion.

### ARTICLE II: NOMINATIONS AND ELECTIONS

Section A. The Leadership Council will supervise nomination and election procedures. The Immediate Past President will chair the Nominating Committee.

Section B. Officers will be elected to two-year terms.

Section C. Members-at-Large will be elected to two-year terms, with three being elected each year.

### Section D.

- A general announcement of the upcoming elections will occur at the April meeting.

### **ARTICLE III: COMMITTEES**

Section A. The Planning Council will establish such commit tees as needed, both standing and ad hoc. Section B. The President of DMACC Pioneers will appoint committee members.

### **ARTICLE IV: MEMBERSHIP DUES**

Section A. No dues will be assessed to members of the DMACC Pioneers. In lieu of membership fees, members will be expected to make financial contributions and/or participate in fund raising activities to support the Pioneers Scholarship, Special Purpose and/or Endowment Funds through the DMACC Foundation.

### ARTICLE V: AMENDMENTS

Section A. Any provision of these procedures may be suspended, altered or amended by majority vote of the Leadership Council and approved by a majority of members in attendance at the meeting in which the vote is taken.
